



Steve as discussed the following are items from the State Electrical Inspector Comments that I want to include as addendum 1.

1. Reduce circuit breaker size at generator from 225A/2P to 200A/2P.
2. Remove main bonding jumper, and separate ground from neutrals in existing main panel per NEC article 250.24.
3. Revise ground wire from #6 AWG to #4 AWG.
4. Furnish and install a nameplate on main switch indicating alternate power source form generator.
5. Furnish and Install a monitor module installed on the existing fire alarm system to indicate generator run status. Run status to be programmed as a supervisory signal only. Provided all required appurtenances required for a complete and operational system. Furnish and install 1/2" conduit from the automatic transfer switch to monitor module/fire alarm control panel. Include in the bid, cost for a factory representative for final tie in and any required programming.






